

## NKWD RATE ADJUSTMENT

The Northern Kentucky Water District (NKWD) filed an application for a rate adjustment with the Kentucky Public service Commission (PSC). Approved by the PSC January 15, 2016, the two-year phase in of the adjustment will mitigate the impact to its customers. The first adjustment will be implemented in the first quarter of 2016. The average residential customer bill\* will be adjusted approximately 5 cents per day, or \$1.49 per month (from \$32.19 per month to \$33.68 per month), or \$4.45 per quarter (from \$96.58 per quarter to \$101.03 per quarter) for a 4.63% adjustment. The second adjustment is anticipated to become effective in early 2017. The average customer bill will be adjusted approximately 5 cents per day, or \$1.48 per month (from \$33.68 per month to \$35.16 per month) or \$4.45 per quarter (from \$101.03 per quarter to \$105.48 per quarter) for a 4.39% adjustment. The major drivers for these rate adjustments: operating costs of mandated and unfunded EPA regulations (Granular Activated Carbon), declining demand, escalating operational costs for power, fuels, and materials, as well as the full impact of the debt service for the capital projects to implement the Granular Activated Carbon system. NKWD's last rate application was three years ago in 2012.

After much deliberation on the most recent rate application to the PSC, NKWD took these factors into account: the current economic conditions of the Northern Kentucky region; its need for additional revenues; how the rate adjustment would impact customers; and the local tolerance for rate increases from utility companies. NKWD asked for less than it could have justified and spread the adjustment out over two years to lessen the impact on its customers.

The filing of the rate application is part of a very rigorous, thorough, and public process with the PSC. The PSC has a detailed public involvement process that NKWD fully cooperates with as part of its filing for any rate adjustment: 1) NKWD must place three ads in the local paper to notify the public of the filing; and 2) Customers have the opportunity to comment by phone, fax, email, in writing, or appear in person at any public hearing scheduled by the PSC. The PSC also closely regulates NKWD by requiring annual independent audits, annual inspection and review of NKWD operations, annual reporting of financial data, and oversight of construction projects, rates, fees, and service standards.

## Significant steps in the PSC process:

- May 1, 2015 Notice of Intent to File per PSC requirements.
- **June 30, 2015** NKWD filed rate adjustment application with PSC.
- Legal notices were placed in the publication of general circulation in the NKWD service area notifying the public of the rate adjustment request – June 30, July 7 & 14, 2015 (The Enquirer – daily paper)
- July 20, 2015 PSC accepted application
- January 15, 2016 Rate adjustment approved by PSC
- January 2016 First adjustment of rates implemented in first billing cycle of 2016.
- January 2017 Second adjustment of rates implemented in first billing cycle of 2017.
