

## NKWD RATE ADJUSTMENT

The Northern Kentucky Water District (NKWD) application for a rate adjustment has been approved by the Kentucky Public service Commission (PSC). The two-year phase in of the adjustment will mitigate the impact to its customers. The first adjustment was implemented February 8, 2023. The average residential customer bill\* was adjusted approximately 9 cents per day, or \$2.80 per month (from \$38.78 per month to \$41.58 per month), or \$8.39 per quarter (from \$116.34 per quarter to \$124.74 per quarter) for a 7.2% adjustment. The second adjustment will become effective on February 8, 2024. The average customer bill will be adjusted approximately 9 cents per day, or \$2.74 per month (from \$41.58 per month to \$44.32 per month) or \$8.23 per quarter (from \$124.74 per quarter to \$132.97 per quarter) for a 6.6% adjustment. The major drivers for these rate adjustments: recover rates to maintain aging infrastructure through associated depreciation, and associated debt service coverage, partially offset the demand forces not controllable by the District resulting in declining consumption, and recover operating and maintenance expense. NKWD's last rate application was in 2018.

After much deliberation on the most recent rate application to the PSC, NKWD took these factors into account: the current economic conditions of the Northern Kentucky region; its need for additional revenues; how the rate adjustment would impact customers; and the local tolerance for rate increases from utility companies. NKWD spread the adjustment out over two years to lessen the impact on its customers.

The filing of the rate application is part of a very rigorous, thorough, and public process with the PSC. The PSC has a detailed public involvement process that NKWD fully cooperates with as part of its filing for any rate adjustment: 1) NKWD must place three ads in the local paper to notify the public of the filing; and 2) Customers have the opportunity to comment by phone, fax, email, in writing, or appear in person at any public hearing scheduled by the PSC. The PSC also closely regulates NKWD by requiring annual independent audits, annual inspection and review of NKWD operations, annual reporting of financial data, and oversight of construction projects, rates, fees, and service standards.

## Significant steps in the PSC process:

- May 27, 2022 Notice of Intent to File per PSC requirements.
- July 8, 2022 NKWD filed rate adjustment application with PSC.
- Legal notices were placed in the publication of general circulation in the NKWD service area notifying the public of the rate adjustment request July 8, 15, & 22, 2022 (*The Enquirer* daily paper)
- July 22, 2022 PSC accepted application.
- **February 8, 2023** Rate adjustment approved by PSC. First adjustment of rates implemented in first quarter billing cycle of 2023.
- February 8, 2024 Second adjustment of rates implemented in the first quarter of 2024.

The daily and monthly price of water for the average customer is still a good buy when compared to other monthly bills such as electric, cable, gas, cell phone, etc. In fact, the daily cost (approx. \$1.48/day) is less than the cost of a 20 ounce soft drink, bottled water, gourmet cup of coffee, or gallon of milk.
